Troup County Seeks Community Input for Upcoming Zoning Public Meeting

Troup County, Ga. November 26, 2018 – Troup County is hosting a Zoning Public Meeting on December 10, 2018 at 5:30PM to discuss changes to County development and zoning codes, and we would like to invite the community to attend to contribute ideas and feedback for the improvement of Troup County. The meeting will be held at the Mike Daniel Recreation Center, 1220 Lafayette Parkway, LaGrange, GA 30241.

The County is currently updating County regulations pertaining to development and zoning to develop a Unified Development Ordinance (UDO). This community forum will offer a chance to meet with Troup County staff to learn more about this process and to contribute ideas in relation to how the development and zoning codes could be improved.
